OFFICIAL RULES

Blitz Champz Super Bowl 2024 Sweepstakes

The following sweepstakes is intended for play in the United States of American only (not to include the states of New York, Rhode Island, or Florida) and except where prohibited. Any entries received from outside the United States of America, or from within the states of New York, Rhode Island, or Florida, will not be included in this sweepstakes. If you are not located within the United States of America, or reside in New York, Rhode Island, or Florida, do not enter this sweepstakes. All entrants must be eighteen (18) years of age or older to enter. Void where prohibited.

SWEEPSTAKES PERIOD: Blitz Champz Super Bowl 2024 Sweepstakes (the "Promotion") begins at 12:00:01 AM Eastern Time ("ET") on July 26, 2023 and ends at 12:00:00 AM ET on December 31, 2023 (the "Promotion Period"). The Promotion contains a game of chance ("Sweepstakes").

1. **ELIGIBILITY:** The Promotion is open only to legal residents of the United States (not to include the states of New York, Rhode Island, or Florida), who are 18 years of age or older as of date of entry and are located within the United States (not to include the states of New York, Rhode Island, or Florida) at the time of entry. Void where prohibited. Employees of Gridiron Queendom, LLC (the "Sponsor"), and any other organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion of the

Sweepstakes, members of their households and immediate families, and their respective parent companies, subsidiaries, agents, and affiliates and the advertising and promotions agencies and all local sponsors are not eligible to enter or win. "Immediate family members" shall mean spouses, parents, stepparents, children, stepchildren, siblings, stepsiblings, and their respective spouses. "Household members" shall mean people who share the same residence at least three months a year. Sponsor reserves the right to conduct a background check on any potential winner and reserves the right in its sole discretion to disqualify any person based upon such background check if Sponsor determines in its sole discretion that awarding the prize to such potential winner might reflect negatively on the Sponsor.

2. HOW TO ENTER THE PROMOTION: Below describes the way to enter the Blitz Champz Super Bowl 2024 Sweepstakes

- Entrants can enter the Sweepstakes via online method only by registering their Blitz Champz deck at <https://www.blitzchampz.com/deck-registration> or entering the Sweepstakes at <https://www.blitzchampz.com/sweepstakes> (the "Websites") during the Promotion Period. Entrants must complete the registration form by filling out the required fields (required fields include: Full Name, Email Address, Full Address, and Birth Date). Upon registering, each eligible, completed registration form received will earn one (1) entry into the Promotion.

APPLICABLE TO ALL ENTRIES: Limit of one (1) entry per person, per email address, per day, regardless of method of entry. Entries in excess of this limit will be disqualified, if discovered by Sponsor. No responsibility is assumed for (i) technical, electronic, telephone, hardware, software or network, computer or data transmission errors, malfunctions or difficulties of any kind or (ii) any incorrect data contained in any Promotion entry.

- 3. SPONSOR RIGHTS:** Sponsor reserves the right, in its sole discretion, to (i) verify any element of any entry, related materials or entrant's eligibility; (ii) disqualify any entrant whose participation may subject the Sweepstakes, Sponsor or Sponsor's advertisers, clients, or customers to controversy, negative publicity, scorn or ridicule; and (iii) to request additional information. By entering the Sweepstakes, you acknowledge and agree that Sponsor may request, and you will provide any documentation or information deemed necessary by, and in a form acceptable to, Sponsor to satisfy these requirements. A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the email address associated with the winning Entry. If, in Sponsor's sole determination, a dispute cannot be resolved, the Entry will be deemed ineligible. Entries generated by a script, macro or other automated means will be disqualified. Entries that are incomplete, garbled, or corrupted are void and will not be accepted.

4. **SWEEPSTAKES DRAWING/ODDS:** On or about **January 10, 2024**, Sponsor will conduct a random drawing from all eligible Entries within the Promotion Period and select one (1) conditional Sweepstakes Prize winner. Potential/conditional winner is subject to verification of eligibility by Sponsor. If a Conditional/potential winner cannot be contacted or if the prize or prize notifications is returned as undeliverable, the Conditional/Potential winner forfeits their prize and Sponsor may award the applicable prize to a selected Alternate Conditional/Potential Winner.
6. **PRIZE:** One (1) Grand Prize will be awarded, consisting of two (2) tickets to Super Bowl 2024 LVIII for the winner and one (1) guest.

The Approximate Retail Value ("ARV") of the Sweepstakes Prize is \$20,000.00

Sponsor reserves the right, at its sole discretion, to substitute prize (or portion thereof) with one (1) of comparable or greater value. Winner is responsible for all applicable federal, state and local taxes, if any, as well as any other costs and expenses associated with prize acceptance and use not specified herein. All prize details are at the Sponsor's discretion.

7. **GRAND PRIZE RESTRICTIONS:** Actual prize value may vary. Any difference between stated value and actual value will not be awarded. Winner is responsible for lodging and transportation to and from Super Bowl 2024 LVIII. Certain restrictions, as determined by Sponsor, may apply. If winner and guest cannot comply with these restrictions or any other portion of these Official Rules, the prize will be forfeited in its entirety and an alternate winner will be chosen. If

winner and guest cannot travel to Super Bowl 2024 LVIII, the prize will be forfeited in its entirety and the prize may be awarded to an alternate winner selected in a random drawing from among all remaining eligible entries. The Super Bowl 2024 LVIII tickets will be determined at the sole discretion of Sponsor. If any portion of the prize is not available for any reason then the Sponsor reserves the right to substitute that portion of the prize with another prize of comparable or greater value. Guest must be of legal age of majority in his/her jurisdiction of residence (and at least 18), unless the child or legal ward of winner, and must complete and return a publicity and liability release within five (5) days of date of issuance. If guest is the child or legal ward of the winner, winner must execute and return all required documents on behalf of such child or legal ward. 10. **GENERAL CONDITIONS:** In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Promotion materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. All decisions as to these Official Rules and interpretations thereof are exclusively within the sole discretion of the Sponsor and may be changed from time to time without notice. The Sponsor reserves the right to cancel or modify the Promotion at any time without notice.
11. **LIMITATIONS OF LIABILITY:** The Sponsor assumes no responsibility or liability for (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or garbled registrations or a combination thereof, entries, URLs, or emails; (b) any incorrect or inaccurate Entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of Entries or registrations at any point in the operation of this Promotion; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Promotion or human error; (e) inaccessibility or unavailability of the Internet or the Websites or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties which may occur in connection with the administration of the Promotion, the processing of Entries, social networking posts, or registrations, the announcement of the prizes, or in any other Promotion-related materials; or (f) any injury or damage to participants or to any other person's computer which may be related to or resulting from any attempt to participate in the Promotion. 13. **CHOICE OF LAW AND JURISDICTION:** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrants or winners, and Gridiron Queendom, LLC in connection with this Promotion, shall be governed by, and construed in accordance with, the laws of the state of New York, without giving effect to any choice of law or conflict of law rules or provisions (whether of the state of New York or any other jurisdiction), which might otherwise cause the application of the laws of any jurisdiction other than the state of New York. Any action or litigation seeking legal or equitable relief arising out of or relating to the Promotion or these Official Rules shall be brought only in the federal or state courts of the state of New York. You expressly consent to the jurisdiction of and venue in such courts and waive all defenses for lack of jurisdiction and inconvenient forum with respect to such courts. Any and all disputes, claims and causes of action arising out of or in connection with this Promotion, shall be resolved individually, without resort to any forms of class action. You agree to service of process by mail or other methods acceptable under the laws of the state of New York.
